# **RESOLUTION TO AWARD**

BAC Resolution Declaring RGP SUCCESS VENTURES INC. as the Lowest Calculated and Responsive Bidder and Recommending the Issuance of the Contract/Purchase Order

**WHEREAS**, the Schools Division Office of San Carlos City (Pangasinan) through the Bids and Awards Committee (DBAC) issued the Invitation for Request for Quotation to be posted in a conspicuous place within the office premises, DepEd San Carlos City Division Website, PhilGEPS and office social media platform for the project **REPAIR AND MAINTENANCE OF BUILDING AND OTHER STRUCTURES** with Approved Budget of Contract (ABC) of **Five Hundred Eleven Thousand Eight Hundred Five Pesos and 29/100 (Php511,805.29).** 

**WHEREAS,** Section 48.1 of the Revised Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the Government Procurement Reform Act of 2009, allows an agency to resort to alternative mode subject to the prior approval of the HOPE, and whenever justified by the conditions provided in this Act, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement provided in this Rule. In all instances, the Procuring Entity shall ensure that the most advantageous price for the Government is obtained.

**WHEREAS**, further, section 53.9 of the Revised IRR of RA 9184 allows an agency to resort to Small Value Procurement where the procurement does not fall under Shopping of Section 52 of the revised IRR and the amount involved does not exceed the thresholds prescribed in Annex "H" of the revised IRR in the amount of One Million Pesos (P 1,000.000.00) for NGAs, GOCCs, GFIs, and SUCs.

**WHEREAS,** the office received two (2) quotations from two (2) prospective contractors, details of which is herein summarized:
