- 1. In view of the two (2) consecutive failed biddings of the **Procurement of Nutritious**Food Products for the Implementation of SBFP for SY 2025-2026 "Lot B
 Procurement of Iron- Fortified Rice (IFR)", the Schools Division Office of San

 Carlos City (Pangasinan) now invites interested bidders to participate for the negotiation

 of the abovementioned project, in accordance with Section 53.1 of the 2016 revised

 Implementing Rules and Regulation of RA 9184.
- 2. The Department of Education (DepEd) Schools Division Office of San Carlos City (Pangasinan), through the Bids and Awards Committee, intends to procure Procurement of Nutritious Food Products for the Implementation of SBFP for SY 2025-2026 "Lot B- Procurement of Iron- Fortified Rice (IFR)" with an Approved Budget for the Contract (ABC) of One Million, Five Hundred Seventy-Two Thousand, One Hundred and Twenty Pesos (Php1,572,120.00).
- 3. The *Schools Division Office of San Carlos City (Pangasinan)*, through its Bids and Awards Committee (BAC), now invites technically, legally, and financially capable suppliers for the said project.
- 4. The Procurement procedure for this requirement is Negotiated Procurement for Two-Failed Bidding pursuant to Section 53.1 of 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 5. The selection of the successful offer shall be based on the best and final offer that will be submitted on **23 October 2025 at 10:00 A.M.** to the Bids and Awards Committee and which would meet the minimum technical specifications required.
- 6. The Schools Division Office of San Carlos City, *Pangasinan* will hold the Negotiation Meeting on **17 October 2025 at 10:00 AM** via MS Teams Videoconferencing through this link: https://tinyurl.com/utzbw8e4.
- 7. Opening of eligibility documents and proposals will be held on October 23, 2025, 10:30 AM at the 2nd floor, Conference Hall, Schools Division Office of San Carlos City, Pangasinan.

Three (3) copies of the proposals (one original and two photocopy) must be submitted to the BAC which must be duly received by the RECORDS OFFICE through manual submission at the Schools Division Office of San Carlos City, Pangasinan on or before 10:00 AM of October 23, 2025. Late submission shall not be accepted.

Technical Requirements for Suppliers:

- The supplier should be certified by DOST-FNRI as Technology Adoptor for Iron-Fortified Rice. The Manufacturer shall be the priority in the supply of goods.
- In cases when traders bid for supply, they
 must be authorized to supply Iron-Fortified

	For purposes of the Contract, "EXW," "FOB," "FCA," "CIF," "CIP," "DDP" and other trade terms used to describe the obligations of the parties shall have the meanings assigned to them by the current edition of INCOTERMS published by the International Chamber of Commerce, Paris. The Delivery terms of this Contract shall be as follows:
	For Goods supplied from abroad, the delivery terms applicable to the Contract are DDP delivered to Department of Education (DepEd) Division of San Carlos City (Pangasinan). In accordance with INCOTERMS."
	For Goods supplied from within the Philippines, the delivery terms applicable to this Contract are delivered Department of Education (DepEd) Division of San Carlos City (Pangasinan) . Risk and title will pass from the Supplier to the Procuring Entity upon receipt and final acceptance of the Goods at their final destination."
	Delivery of the Goods shall be made by the Supplier in accordance with the terms specified in Section VI (Schedule of Requirements).

The Supplier shall carry sufficient inventories to assure ex-stock supply of consumable spare parts or components for the Goods for a period.

Spare parts or components shall be supplied as promptly as possible, but in any case, within one month of placing the order..

Packaging -

The Supplier shall provide such packaging of the Goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in this Contract.

The packaging shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packaging case size and weights shall take into consideration, where appropriate, the remoteness of the Goods' final destination and the absence of heavy handling facilities at all points in transit.

The packaging, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the Contract, including additional requirements, if any, specified below, and in any subsequent instructions ordered by the Procuring Entity.

Transportation -

Where the Supplier is required under Contract to deliver the Goods CIF, CIP, or DDP, transport of the Goods to the port of destination or such other named place of destination in the Philippines, as shall be specified in this Contract, shall be arranged and paid for by the Supplier, and the cost thereof shall be included in the Contract Price.

Where the Supplier is required under this Contract to transport the Goods to a specified place of destination within the Philippines, defined as the Project Site, transport to such place of destination in the Philippines, including insurance and storage, as shall be specified in this Contract, shall be arranged by the Supplier, and related costs shall be included in the contract price.

The Procuring Entity accepts no liability for the damage of Goods during transit other than those prescribed by INCOTERMS for DDP deliveries. In the case of Goods supplied from within the Philippines or supplied by domestic Suppliers risk and title will not be deemed to have passed to the Procuring Entity until their receipt and final acceptance at the final destination.
