In view of the two (2) consecutive failed biddings of the **Procurement of Nutritious Food Products for the Implementation of SBFP for SY 2025-2026 "Lot E-Procurement of Cookies"**, the Schools Division Office of San Carlos City (Pangasinan) now invites interested bidders to participate for the negotiation of the abovementioned project, in accordance with Section 53.1 of the 2016 revised Implementing Rules and Regulation of RA 9184.
2. The *Department of Education (DepEd) Schools Division Office of San Carlos City (Pangasinan)*, through the Bids and Awards Committee, , using the for **FY 2025 GAA (Sub-ARO No. ROI-25-0083)** intends to procure **Procurement of Nutritious Food Products for the Implementation of SBFP for SY 2025-2026 "Lot E-Procurement of Cookies"** with an Approved Budget for the Contract (ABC) of **Three Million, One Hundred Forty-Four Thousand, Two Hundred and Forty Pesos (Php3,144,240.00)**.
3. The *Schools Division Office of San Carlos City (Pangasinan)*, through its Bids and Awards Committee (BAC), now invites technically, legally, and financially capable suppliers for the said project.
4. The Procurement procedure for this requirement is Negotiated Procurement for Two-Failed Bidding pursuant to Section 53.1 of 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
5. The selection of the successful offer shall be based on the best and final offer that will be submitted on **25 November 2025 at 10:00 A.M.** to the Bids and Awards Committee and which would meet the minimum technical specifications required.
6. The Schools Division Office of San Carlos City, *Pangasinan* will hold the Negotiation Meeting on **21 November 2025 at 10:00 AM** via MS Teams Videoconferencing through this link: <https://tinyurl.com/utzbw8e4>.
7. Opening of eligibility documents and proposals will be held on **November 25, 2025, 10:30 AM at the 2nd floor, Conference Hall, Schools Division Office of San Carlos City, Pangasinan.**

Three (3) copies of the proposals (one original and two photocopy) must be submitted to the BAC which must be duly received by **the RECORDS OFFICE through manual submission at the Schools Division Office of San Carlos City, Pangasinan on or before 10:00 AM of November 25, 2025.** Late submission shall not be accepted.

The quantity specified in the Purchase Request represents the total number of feeding days for 120 days for the whole Division of San Carlos City. Distribution lists for each drop-off point will be provided separately after the conduct of the Division-wide Nutritional Assessment (Height and Weight taking), and accomplishment of Baseline Nutritional Status Report for SY 2025-2026.

The additional guidelines on the procedures of Inspection and Delivery are detailed as follows:

1	Delivery and Documents – See Annexes For purposes of the Contract, “EXW,” “FOB,” “FCA,” “CIF,” “CIP,” “DDP” and other trade terms used to describe the obligations of the parties shall have the meanings assigned to them by the current edition of INCOTERMS published by the International Chamber of Commerce, Paris. The Delivery terms of this Contract shall be as follows: <i>For Goods supplied from abroad, the delivery terms applicable to the Contract are DDP delivered to Department of Education (DepEd) Division of San Carlos City (Pangasinan). In accordance with INCOTERMS.”</i> <i>For Goods supplied from within the Philippines, the delivery terms applicable to this Contract are delivered Department of Education (DepEd) Division of San Carlos City (Pangasinan). Risk and title will pass from the Supplier to the Procuring Entity upon receipt and final acceptance of the Goods at their final destination.”</i> Delivery of the Goods shall be made by the Supplier in accordance with the terms specified in Section VI (Schedule of Requirements).
