WHEREAS, pursuant to *Section 31.2* of the Implementing Rules and Regulations (IRR) of Republic Act No. 12009 (*New Government Procurement Act*) allows an agency to resort to Direct Contracting where the goods are proprietary nature which can be obtained only from the proprietary source or when patents, trade secrets, and copyrights prohibit others from manufacturing the same item, as supported by relevant documentary evidence issued by competent authority, *section 31.2.b*, When the procurement of critical components from a specific manufacturer, supplier, or distributor is a condition precedent to hold a service provider to guarantee its project performance, in accordance with the provisions of the contract, as determined by the End-User or Implementing Unit; or, *section 31.2.c*, sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the government;

WHEREAS, a Request for Quotation/Pro-Forma Invoice was sent to **CUNANAN MAP HOUSE** on **April 23, 2026**, and they submitted their price quotations dated **April 24, 2026, 2:51 PM** amounting **ONE HUNDRED SIXTEEN THOUSAND, NINE HUNDRED TEN PESOS (Php 116,910.00)**;
