**BAC RESOLUTION RECOMMENDING SMALL VALUE PROCUREMENT AS A MODE OF PROCUREMENT FOR THE *PROCUREMENT OF MEALS AND SNACKS INCLUSIVE OF TARPULIN, VENUE AND ACCOMMODATION FOR THE CONDUCT OF DIVISION WORKSHOP ON ADVANCING HRD POLICIES AND PROGRAMS***

**Resolution No. 039; Series of 2026**

**WHEREAS**, the Department of Education (DepEd), Schools Division Office of San Carlos City, Pangasinan, through its Bids and Awards Committee (BAC), intends to procure the project entitled *Procurement of Meals and Snacks inclusive of Tarpaulin, Venue and Accommodation for the conduct of Division Workshop on Advancing HRD Policies and Programs*;

**WHEREAS**, pursuant **Section 34.1 of the 2024-2025 Implementing Rules and Regulations (IRR) of Republic Act No. 12009**, "*Small Value Procurement is a mode of procurement of Goods not available in the PS-DBM, Infrastructure Projects, and Consulting Services whereby the Procuring Entity requests for the submission of at least three (3) price quotations*";

**WHEREAS**, Section 34.2 of the same IRR provides that the **project's Approved for the Contract (ABC) in the amount of One Hundred Ninety-Six Thousand Pesos (Php196,000.00)** is within the threshold for Small Value Procurement for Goods, which is Two Million Pesos (Php2,000,000.00) and below, pursuant to Section 34 of Republic Act No. 12009 and its 2024-2025 Implementing Rules and Regulations (IRR);

**WHEREAS**, consistent with Section 34.4 of the IRR, "the supplier, contractor, or consultant with the lowest calculated quotation shall be awarded the contract, provided that the quotation is responsive to the RFQ and the conditions of sale are acceptable to the Procuring Entity";

**NOW THEREFORE**; for and in consideration of the foregoing premises, the **Bids And Awards Committee (BAC) hereby RESOLVES**, as it is hereby resolved, to RECOMMEND to the Head of the Procuring Entity (HOPE) the adoption of SMALL VALUE PROCUREMENT, pursuant to Section 34 of Republic Act No. 12009 and its 2024-2025 Implementing Rules and Regulations, as the mode of procurement for the project *Procurement of Meals and Snacks inclusive of Tarpaulin, Venue and Accommodation for the conduct of Division Workshop on Advancing HRD Policies and Programs*.


**RESOLVED**, finally, that this resolution shall form part of the official procurement records of the project.




