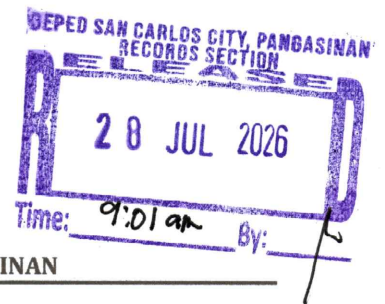

The postponement is made pursuant to **BAC Resolution No. 080, s. 2026**, due to the need to correct a material inconsistency between the Technical Specifications and the approved Menu Schedule through the issuance of a **Supplemental/Bid Bulletin**, in accordance **with Sections 51.4 and 51.5.2 of the 2026 Implementing Rules and Regulations (IRR) of Republic Act No. 12009**.

Since the Supplemental/Bid Bulletin could not be duly approved and posted at least seven (7) calendar days before the scheduled deadline for the submission and opening of bids, the Bids and Awards Committee (BAC) deemed it necessary to postpone the bid opening pursuant to **Section 58.4 of the 2026 IRR of Republic Act No. 12009**, in order to uphold the principles of transparency, competitiveness, fairness, accountability, and equal opportunity in the procurement process.

Accordingly, the scheduled procurement activities are hereby postponed until further notice.

The BAC Secretariat shall issue the corresponding **Supplemental/Bid Bulletin** and a separate **Notice of Rescheduled Bid Opening** upon compliance with the posting and notification requirements prescribed under the 2026 IRR of Republic Act No. 12009.

All prospective bidders are advised to regularly monitor the Philippine Government Electronic Procurement System (PhilGEPS), the DepEd official website, and the BAC Bulletin Board for the issuance of the Supplemental/Bid Bulletin and the Notice of Rescheduled Bid Opening.
