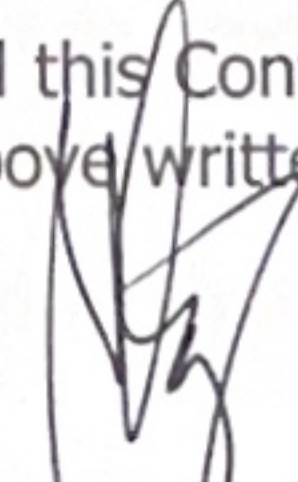
NOW, THE PARTIES AGREE AS FOLLOWS:

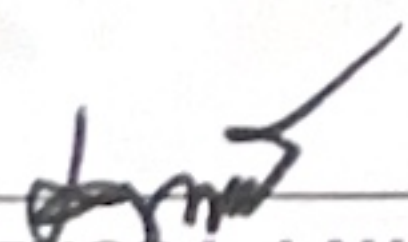

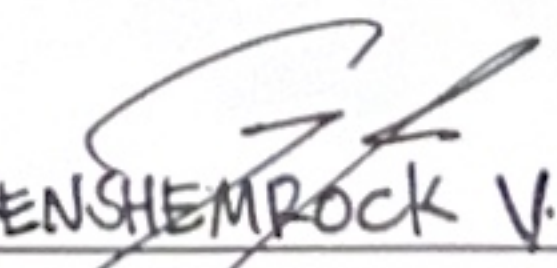
